Details of Session (including aim and scope): Cyber activity has become an essential part of our life. The hacking threats of cybercrime are becoming more sophisticated than ever. The challenges in cybercrime investigations have created a strong need for digital forensics. Digital forensics aims to identify, collect, examine, analyze, and present digital evidence to prosecute cybercriminals in the court of law. This session explores the challenges faced by researchers and practitioners in the area of cybercrime investigations and digital forensics. Attendees will benefit from each other's resources and expertise in the domain. The session covers, but is not limited to, the following topics: 1) Cybercrime Investigation: Cybercrime and: terrorism, criminology, challenges and countermeasures, international laws, scene investigation, laws and procedures, international attacks and response. 2) Digital Forensics: Digital forensics and: challenges and countermeasures, Big data, Network, Systems, Application, Cloud, IoT, Drone, Data recovery. 3) Big Data Approach for Cybercrime Investigation: Network packets on the intranet, Timestamp metadata of digital objects, Automated data extraction, Anomalies detection, Machine-learning based model, Timeline reconstruction.
